

**EXECUTIVE ORDER NO. 21**  
**Series of 2022**

**"AN ORDER REORGANIZING THE BIDS AND AWARDS COMMITTEE,  
BAC SECRETARIAT AND TECHNICAL WORKING GROUP  
AND DEFINING FUNCTIONS THEREOF"**

**WHEREAS**, Section 3 (b), Chapter 1, Title I, Book I of the R. A. 7160, otherwise known as The Local Government Code of 1991 (*LGC for brevity*) provides that "There shall be established in every local government unit an accountable, efficient, and dynamic organizational structure and operating mechanism that will meet the priority needs and service requirements of its communities";

**WHEREAS**, it is the policy of the state to promote good governance and adhere to the principles of transparency, accountability, equity, efficiency and economy in every procurement process;

**WHEREAS**, Republic Act No. 9184 prescribes for the rules and regulations for the modernization, standardization and regularization of the procurement process in government;

**WHEREAS**, Chapter 11.2.6 of the 2016 Revised Implementing Rules and Regulations of R. A. 9184 provides that "Unless sooner removed for a cause, the members of the BAC shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the HoPE. ...";

**WHEREAS**, (1)(b) of Sec. 444 Title III, Book III of the LGC provides that the "Local Chief Executive shall exercise general supervision and control over all programs, projects, services, and activities of the provincial government... and (x) ensure that all executive officials and employees of the province faithfully discharge their duties and functions as provided by law" ...;

**WHEREAS**, the Provincial Government of Biliran, in observance to the aforementioned laws and issuances, recognizes the need for the reorganization of the Bids and Awards Committee;

**WHEREFOR IN VIEW OF THE FOREGOING, I, GERARD ROGER M. ESPINA**, Provincial Governor, Province of Biliran by the virtue of the power vested in me by law **hereby orders the designation of the following functions, to wit:**

**Section 1. TITLE.** This order shall be known as the **BIDS AND AWARDS COMMITTEE (BAC).**

**Section 2. COMPOSITION.** The BAC members shall be composed of the following:

The functions of the BAC Secretariat shall be in accordance with Section 14 of the Implementing Rules and Regulations of R. A. 9148.


**Section 4.2 THE TECHNICAL WORKING GROUP.**
