EXECUTIVE ORDER NO. <u>24</u> Series of 2022

"AN ORDER REORGANIZING THE COMPOSITION OF THE PROVINCIAL PROJECT INSPECTORATE TEAM (PPIT) OF THE PROVINCE OF BILIRAN"

WHEREAS, Section 28, Article II of the 1987 Constitution provides as state policy that, subject to reasonable conditions prescribed by law, the State adopts and implements full public disclosure of all its transactions involving public interest;

WHEREAS, the Local Government Code of 1991 provides for a more responsive and accountable local government structure instituted through a system of decentralization, which enable to discharge expanded fiscal, planning and regulatory powers and functions;

WHEREAS, there is a need for the reorganization of the Provincial Project Inspectorate Team considering the change in composition of members thereof:

WHEREAS, the Provincial Government of Biliran, in observance to the aforementioned laws, recognizes the fundamental importance of inspection and monitoring of various infrastructure programs and projects and related services in the province to effect good governance and transparency in all government transactions accountability, equity, efficiency, and ensure effective utilization of government resources with frugality to complement the growth and development of its constituents;

WHEREAS, (1)(b) of Sec. 444 Title III, Book III of the LGC provides that the "Local Chief Executive shall exercise general supervision and control over all programs, projects, services, and activities of the provincial government... and (x) ensure that all executive officials and employees of the province faithfully discharge their duties and functions as provided by law" ...;

NOW, THEREFORE, I, GERARD ROGER M. ESPINA, Governor of the Province of Biliran, by virtue of the powers and authority vested in me under Section 16, in relation to Section 465 (b) (2) (iii) of the Local Government Code of 1991, do hereby order the reorganization of the composition of the Provincial Project Inspectorate Team (PPIT).

Section 2. FUNCTIONS. The following are the functions of Provincial Project Inspectorate Team:

- To inspect and ensure that all infrastructure projects constructed must be physically complete and correct according to prescribed quality, quantity, specifications, and standards;
- To inspect, supervise, monitor, check, evaluate, assess, and ensure the structural integrity of all provincial buildings, facilities and infrastructure projects;
- c. Monitor the materials expediting/inspection activities;
- d. Ensure material delivered is inspected for conformance to specifications;
- e. Receive and review purchase requisitions;
- f. Ensure quality materials/services delivered/rendered.
- g. Liaise with requesting office personnel to manage timely inspection of the goods on order as well as to arrange for field expediting visits when required; and
- h. Submit regular reports to the Local Chief Executive regarding the tasks assigned hereto;

Section 3. SANCTIONS. Failure or refusal without justifiable cause by any of the members of the Provincial Project Inspectorate Team to perform any of the foregoing duties shall be a ground for imposition of administrative sanctions against the erring official/employee.

Section 4. SEPARABILITY CLAUSE. Any provision of this Executive Order declared illegal shall not nullify the other provisions hereof provided that the remaining provisions can be given force and effect to accomplish the objectives of this Executive Order.

Section 5. REPEALING CLAUSE. All other orders, rules, regulations and issuances or parts thereof which are inconsistent with this Executive Order are hereby repealed or modified accordingly.

This Order shall take effect immediately.
